

## CORONAVIRUS (COVID-19) Vaccine Information

### Vaccine Overview

The U.S. Food and Drug Administration has amended authorization for the Pfizer-BioNTech COVID-19 Vaccine to allow for use of a single booster dose, to be **administered at least six months after** completion of the primary series in:

- **individuals 65 years of age and older;**
- individuals 18 through 64 years of age at high risk of severe COVID-19; and
- individuals 18 through 64 years of age whose frequent institutional or occupational exposure to SARS-CoV-2 puts them at high risk of serious complications of COVID-19 including severe COVID-19.

**This authorization applies only for individuals who received the Pfizer-BioNTech COVID-19 Vaccine.** For more information visit: [cdc.gov/coronavirus/2019-ncov/vaccines/booster-shot.html](https://www.cdc.gov/coronavirus/2019-ncov/vaccines/booster-shot.html).

Anyone **12 years of age and older** is eligible to receive the COVID vaccine.

**The Pfizer vaccine is available to residents age 12 and older. A parent or guardian must be present when teens, under the age of 18 are vaccinated. Both the Moderna vaccine and the Johnson and Johnson vaccine are available for those age 18 and older.**

Even after receiving **both doses** of the vaccine it is important to continue following recommendations for mask wearing, social distancing and hand washing. **Recommendations change as new variants of the virus, which can be more contagious, are circulating in the community. **All vaccination sites require recipients to provide a photo identification card, or two other items (i.e. utility bill, deed, mortgage etc.) that reflect a Florida residential address to receive a vaccination. With the expansion of eligibility, verification of date of birth and place of employment are also required.**

**COVID-19 CDC replacement vaccination record cards can be requested at the health department.** Medical staff at the R & S Clinic (1515 Old Bainbridge Road) can help residents with the process during regular business hours (8 a.m. to 5 p.m.). Individuals who have lost or damaged their cards can get assistance regardless of where they received their dose.

### Vaccine Sites

The **Leon County Health Department** is offering COVID-19 vaccines to eligible individuals on **Tuesdays from 4 p.m. to 7 p.m., and Fridays from 3 p.m. to 6 p.m.** Walk-ups are welcome, **no appointments necessary**. The vaccination site is located at **1515 Old Bainbridge**.

**CDR-Health Center** is offering COVID-19 vaccinations **seven days a week from 7 a.m. to 7 p.m.** to schedule an appointment visit [CDR-Health.com](https://www.cdr-health.com) or call **850-738-7977**. The vaccination site is located at **1981 Capital Circle NE**; appointments preferred, but not required.

**Florida A & M University** is hosting a COVID-19 vaccination site located at **674 Gamble St.** To register visit [Commvax.patientportalfl.com](https://commvax.patientportalfl.com), however, walk-ups are welcome, and registration is not necessary. The site is open from **9 a.m. to 5 p.m., Monday - Saturday**. Recipients can be dropped off and picked up, and disability assistance is available.

**Publix** stores in Leon County are scheduling COVID-19 vaccinations. For more information, visit [publix.com/covid-vaccine/florida](https://publix.com/covid-vaccine/florida). **Bond Community Health Center** offers vaccines **Wednesdays from 9 a.m. to 12 p.m. and 2 p.m. to 4 p.m.** The vaccination site is located at **1720 S Gadsden St**; vaccines are given on a first come, first served basis. **Neighborhood Medical Center** offers vaccines **Monday – Friday from 9 a.m. to 4 p.m.** The vaccination site is located at **872 W. Orange Ave**; to schedule an appointment visit [neighborhoodmedicalcenter.org/](https://neighborhoodmedicalcenter.org/).

Veterans currently receiving care at any NF/SGVHS site can receive a COVID-19 vaccination at the **Sergeant Ernest I. “Boots” Thomas VA Clinic** when supply is available. Spouses and caregivers can receive vaccinations as well. **Walmart/Sam's Club** stores in Leon County are also serving as vaccination sites. Appointments are required at each location. Otherwise, sign in with your Sam's Club membership account information and complete the registration process.

**CVS Pharmacy** is also offering COVID-19 vaccination, visit [cvs.com/immunizations/covid-19-vaccine](https://cvs.com/immunizations/covid-19-vaccine) to schedule an appointment. Once there select your state and city, then complete the registration form.

**Walgreens Pharmacy** is offering vaccines. Users must create a Walgreens account to schedule an appointment. Visit [walgreens.com/findcare/vaccination/covid/19/landing](https://walgreens.com/findcare/vaccination/covid/19/landing) to schedule an appointment.

### Transportation

**211 Big Bend** is working with **Lyft** to provide free transportation to and from vaccination appointments. Rides are available to anyone within Leon County; call **850-617-6325** to schedule transportation for an upcoming appointment. **This option is good for all vaccination sites, except for drive-thru only sites.**

**Elder Care Services** is offering transportation assistance to residents 60 years of age and older to get to community vaccination sites. To request transportation call **850-921-5554**.

**StarMetro is now providing fare free rides to and from COVID-19 vaccine appointments, within the city.** Customers will need to show confirmation of their appointment to the driver when they board the bus. Paratransit service patrons who schedule a ride to or from their COVID-19 vaccine appointment will also enjoy a fare free trip. **This option will not work for drive-thru sites.**
