## **TALLAHASSEE SENIOR CENTER & FOUNDATION**

Together, the TSC and Foundation provide a holistic array of programs and services to approximately 23 percent of the 50+ population in Tallahassee-Leon County with the following goals: to increase socialization, improve and maintain physical and mental health, provide information and education, lifelong learning, resource assistance and other support systems to help participants achieve and maintain optimal health. The programs and services are categorized as follows: health and wellness, fitness, art, lifelong learning, recreation, crafts, arts, music and dance, cards and games, events, fundraisers, outreach, and services.

## **TALLAHASSEE SENIOR SERVICES MISSION**

The mission of Tallahassee Senior Services is to offer programs, activities, and opportunities designed to encourage active living, optimal aging, and social fitness for independent adults age 50+. Tallahassee Senior Services is a division of the City of Tallahassee's Parks, Recreation and Neighborhood Affairs Department. A 15-member Advisory Council, appointed by the Mayor, represents seniors' interests and needs in Tallahassee. TSS is staffed and maintained by support from the City general revenue fund.

## **TALLAHASSEE SENIOR FOUNDATION (TSCF) PURPOSE**

Established in 1980, TSCF is an independent, private non-profit organization that exists for the sole purpose of generating funding to support programs, services and participants of Tallahassee Senior Services. The Foundation, administered by a 15-member Board of Directors, is composed of members elected by the current board. 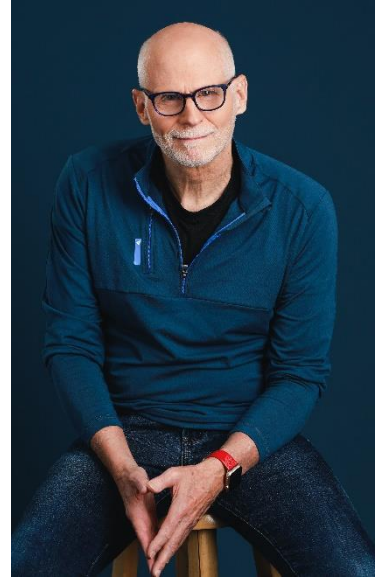

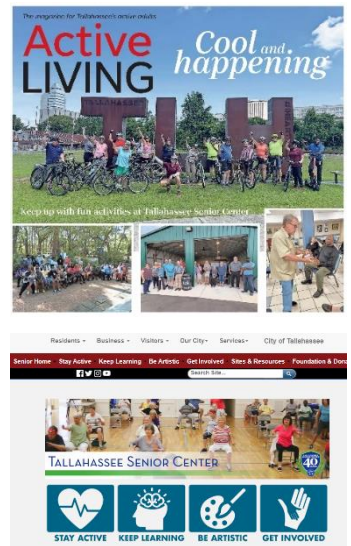

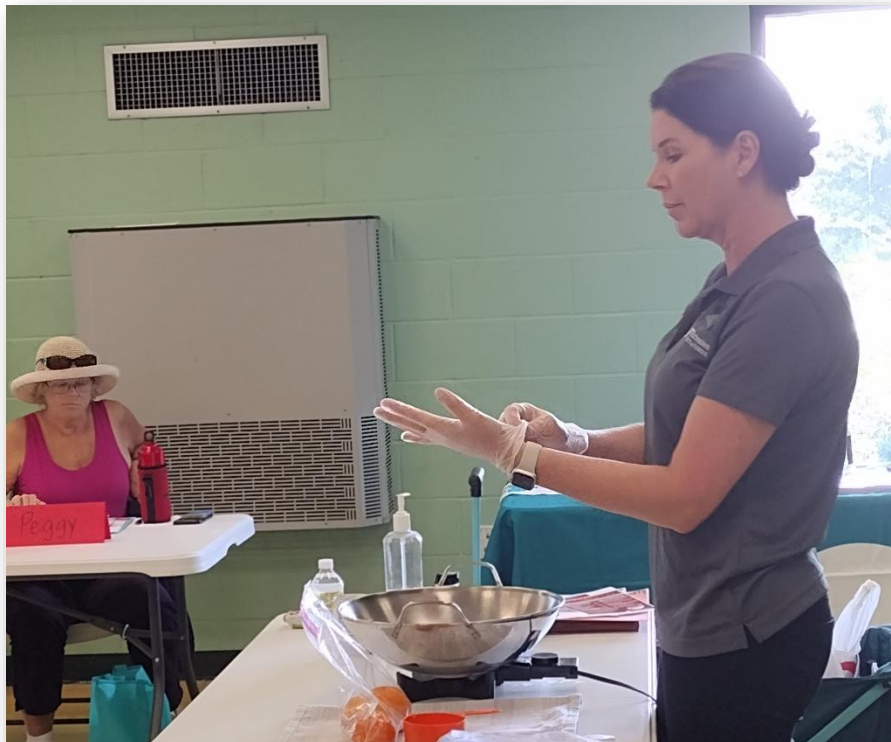

# Leon County Senior Outreach

*A program of the TSC Foundation, funded by Leon County Commissioners, grants, donations, and participant fees*

Monthly Lunch & Learns returned to in-person by February 2022. Seniors in each community enjoyed being together and the LC Senior Outreach staff were also delighted to a return to normal. Each of the six communities offer a new guest speaker each month with topics ranging from healthcare to gardening to animal encounters. Local businesses and community agencies attend as exhibitors to educate seniors about topics that encourage aging in place and remaining active and engaged. Boxed lunches were offered throughout 2022 so participants had the option of eating together or to enjoy at home.

Field trips also resumed in August and September with Miccosukee and Woodville touring the National High Magnetic Field Laboratory and having lunch with the scientists.

Fitness class participation transitioned from outdoor in the fall of 2021 to indoor in 2022 as did Canasta, art classes, and other social groups.

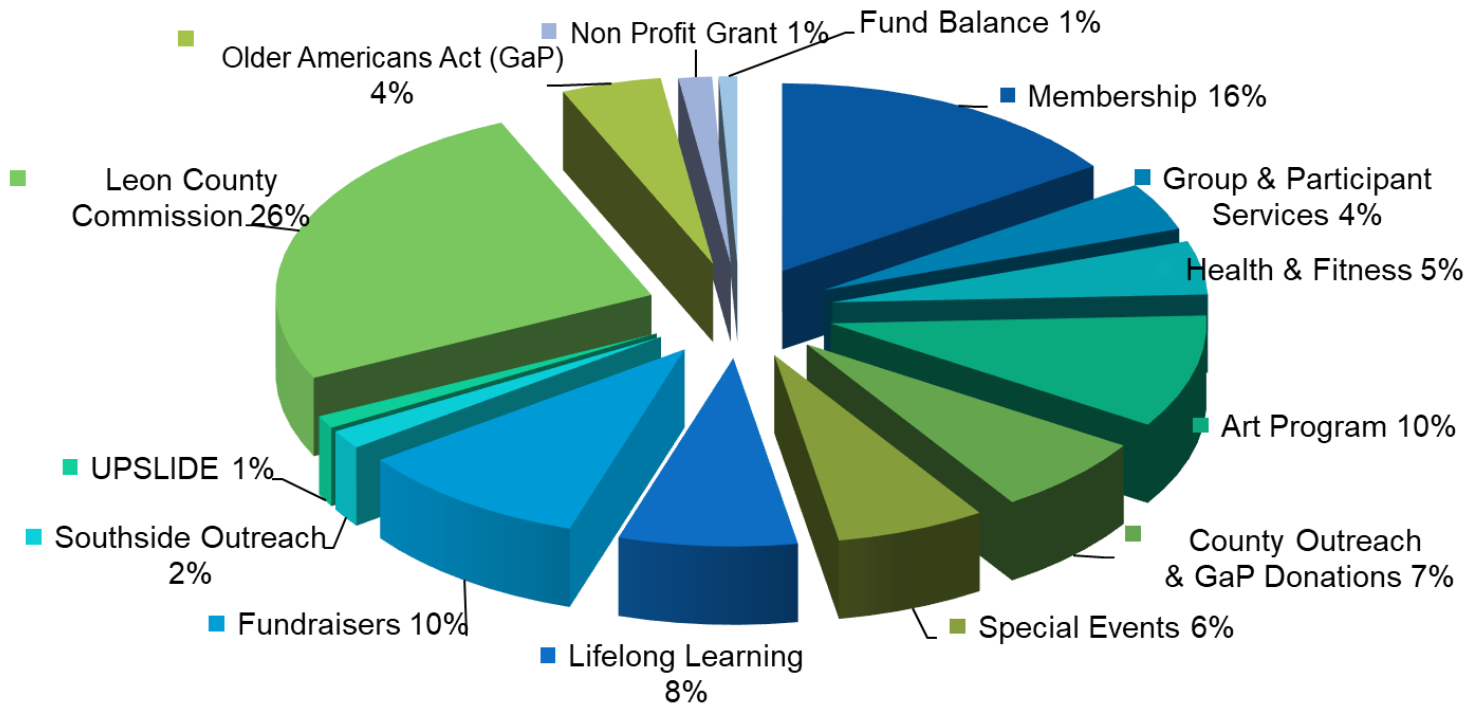

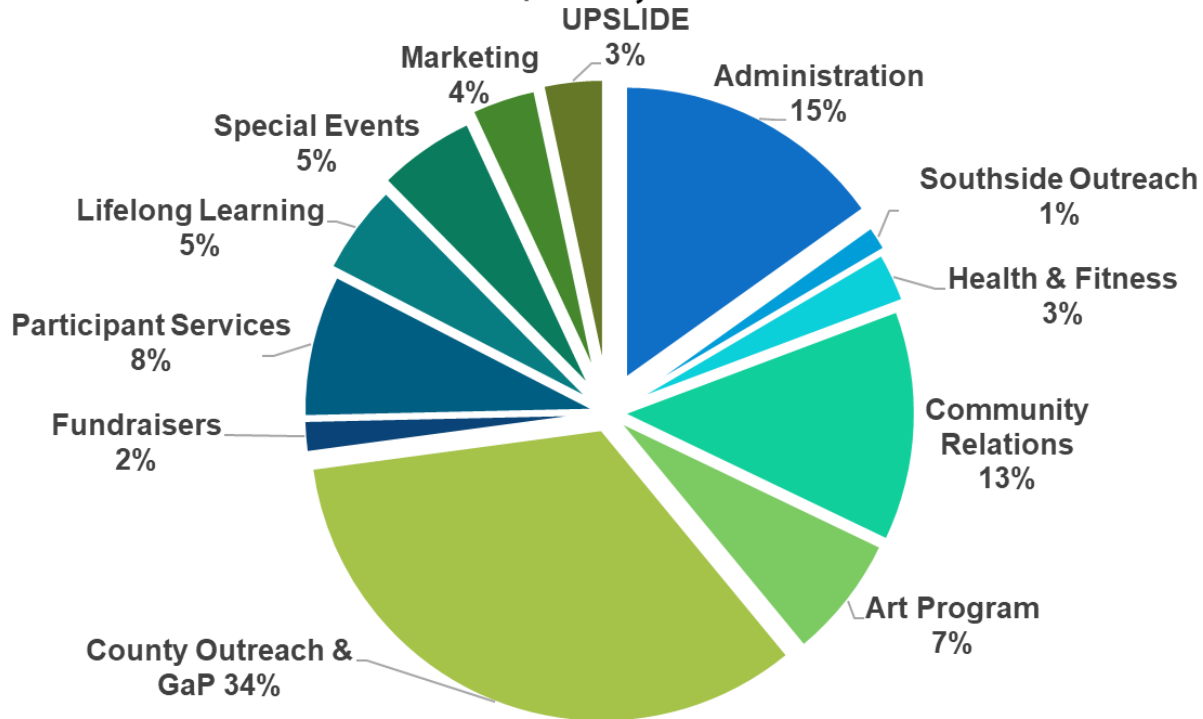
## TSC Foundation Revenue 2022
